## Burcu Tuzcu Ersin Contributes to Employment and Immigration Panel at International Bar Association's 2016 Annual Conference

Moro?lu Arseven Partner, Burcu Tuzcu Ersin, attended and contributed to the 2016 International Bar Association's (IBA) annual conference held in Washington DC from September 18 to 23. During the event, she participated in a panel discussing employment and immigration Issues. During the conference, Burcu Tuzcu Ersin was invited to participate in a panel discussion on employment law and immigration issues, entitled "Welcome to our country! But please, put down that job application". The discussion focused on the employment law aspects of immigration, inclusion and employment opportunities, particularly focussing on right-to-work policies for refugees and asylum-seekers.

The working session involved practitioners from Austria, Australia, England, France, Germany, The Netherlands, Turkey and United States. Panellists discussed hiring of refugees, discrimination, and conditions for employment contracts in their respective countries, as well as recognizing refugee talents, skills and competencies.

Turkey has been amending related legislation recently to enable protection seekers to access the job market properly, as well as indicated that these amendments would continue in order to support overall integration to Turkey.

Within her wider practice, Burcu regularly provides employment law advice and support on compliance aspects, whistleblowing and non-compliance incidents, as well as data protection and privacy related advice.
