Legal arrangements for program formats and production rights tend to involve complicated chains of agreements, with rights passing through many hands. Turkish law requires rights be separately transferred, so understanding how to define and protect naming and adaptation rights is very important for protecting our clients' interests.

For example, recording details about scripts, casting suggestions, set designs, floor plans, logos, costumes, theme tunes, as well as jingles.
