

Moroğlu Arseven and Individual Team Members Recognized in Chambers & Partners Europe 2015 Rankings

Moroğlu Arseven has been ranked as a Band 2 firm for Intellectual Property by Chambers & Partners in its 2015 Europe Edition. Chambers & Partners ranks the firm in Band 4 for its work in both Corporate and M&A, as well as Dispute Resolution. The firm is also noted for its work in Technology, Media, and Telecommunications. Four of the firm's Partners, İzzet Özdoğan, E. Seyfi Moroğlu, Burcu Tuzcu Ersin, and Benan Arseven, are singled out for individual recognition. While two of the firm's Counsels, Gökçe Zengi and Ezgi Baklaci, are also noted.
