

Moroğlu Arseven Receives Top Tier Ranking for Compliance, Intellectual Property, and Media and Entertainment by the Legal 500 in 2020 Awards, Plus Recognized for Seven Other Practice Areas

The Legal 500 ranks Moroğlu Arseven in **Tier 1** for **Compliance, Intellectual Property** as well as **Media and Entertainment** practices, in its 2020 awards. - **Tier 3** for **Energy and Real Estate and Construction**.
- **Tier 4** for **Banking, Finance, and Capital Markets**.

Moroğlu Arseven's **Compliance** practice receives recognition in **Tier 1** for the third year in a row. **The practice leader Burcu Tuzcu Ersin, LL.M.** is acknowledged as "**Leading Individual**" Legal 500 noted that *"the extensive experience of the team is reflected by its work for clients in sectors such as healthcare, fintech, e-commerce, media, advertising, gambling and industrial."* **Dr. Z.
