

## Moroğlu Arseven Recognized in Seven Practice Areas by The Legal 500 2015 Rankings

The Legal 500 awarded rankings to Moroğlu Arseven in seven practice areas for 2015, also recognizing Işık Özdoğan individually as a Leading Individual in the Intellectual Property field. The Legal 500 ranks the firm in Tier 2 for its work in Intellectual Property, Dispute Resolution, and Energy, as well as Tier 3 for Corporate and M&A, plus Employment. The firm is ranked in Tier 4 for its work in Banking, Finance, and Capital Markets, as well as Competition. Eight senior staff members receive recognition by name for their work across a diverse range of practice areas.

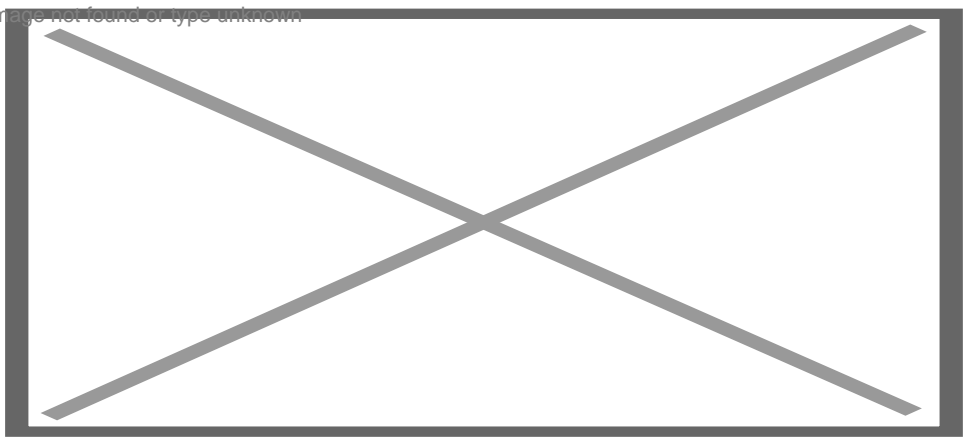
