### Investigation Regarding Imports of "Gas-Fired Instant Water Heaters" from China Ended

The General Directorate of Imports of the Ministry of Trade initiated an investigation to determine whether dumping will continue or re-occur in case the anti-dumping measures applied in "gas-fired instant water heaters" imports from China under tariff code 8419.11.00.00.00 are revoked.

After the investigation, the directorate has decided to apply the following anti-dumping measures:
