This Seminar Participant Privacy Notice has been prepared by Moroğlu Arseven as a data controller, for the purpose to fulfil our obligation to inform on how your personal data is processed, which personal data of yours is obtained or may be obtained during the Seminar due to your participation, under Personal Data Protection Law numbered 6698 (“**DP Law**”).

For the Seminar, your personal data will be processed by the data controller Moroğlu Arseven within the scope described below.

### Collection of Your Personal Data and the Legal Basis

As a participant, your personal data is collected for the purpose of establishing the participation list or through your e-mail address’ and name’s appearance if you participate online, your questions during the Seminar and / or your communication with the speakers who will take place in the Seminar, or through communication channels if you contact us, via automatic or non-automatic means, within the scope of the establishment of the right within the scope of article 5 of the DP Law and your explicit consent.

### Purposes of Processing Personal Data

Your personal data is processed for the purpose of organizing the Seminar, establishing the participant list, recording the Seminar, taking photos, communicating with the Event Stakeholders about the Seminar and through your questions or when the speakers at the Seminar mentions your name.

### Your Personal Data Processed

Your personal data being processed as a participant is as follows:

### Transfer of Your Personal Data to Third Parties and/or Abroad

Your personal data, may be transferred to (i) third party service providers of Moroğlu Arseven in areas such as storage, archiving, hosting (server, hosting, program, cloud computing) in order to carry out information security processes (ii) in case of deciding to publish the Seminar on online platforms, relevant social and sharing channels whose servers are located abroad, (iii) law firms that are Event

Stakeholders in order to confirm the participant list, (iv) in case you participate online, Zoom, whose server is abroad, (v) press and public relations companies after the Seminar, (vi) authorized institutions and organizations to fulfill legal or regulatory obligations or requests, if requested, and (vii) our business partners from whom we receive support within the scope of the Seminar, based on your explicit consent within the framework of the transfer conditions specified in articles 8 and 9 of the DP Law in line with the above-mentioned purposes.

### **Access to Your Personal Data and Your Rights Under the DP Law**

Pursuant to article 11 of the DP Law, data subjects have the right to:

- learn whether his / her personal data are processed or not,
- demand for information as to if his / her personal data have been processed,
- to learn the purpose of the processing of his / her personal data and whether these personal data are used in compliance with the purpose,
- know the third parties to whom his personal data are transferred in country or abroad,
- request the rectification of the incomplete or inaccurate data, if any,
- to request the erasure or destruction of his/her personal data under the conditions referred to in article 7,
- to request reporting of the operations carried out pursuant to sub-paragraphs (d) and (e) to third parties to whom his / her personal data have been transferred,
- object to the occurrence of a result against the person himself/herself by analyzing the data processed solely through automated systems,
- claim compensation for the damage arising from the unlawful processing of his/her personal data.
